AN ORDINANCE to amend The Nevis International Exempt Trust Ordinance, No. 4 of 1994.

[Published 8th October 2009, Official Gazette No. 45 of 2009.]

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Nevis Island Assembly, and by the authority of the same as follows:

1. This Ordinance may be cited as **THE NEVIS INTERNATIONAL EXEMPT TRUST (AMENDMENT) ORDINANCE, 2009** and shall be read as one with The Nevis International Exempt Trust Ordinance, No. 1 of 1994 (hereinafter referred to as "the principal Ordinance").

- 2. Section 37 of the principal Ordinance is amended as follows:
 - (i) in subsection (2) delete the words "within 45 days of the date on which the trust is created, settled or established.
 - (ii) in subsection (3) delete the words "within 45 days of the date on which the trust is created, settled or established.
 - (iii) in subsection (4) delete the words "within 45 days of the date on which the governing law is changed".
 - (iv) in subsection (6)(b) by inserting the words "the name of the trustee" immediately following the words "notice of" occurring therein.
 - (v) in subsection (6) by inserting a new subsection (c)(v) as follows:
 - "(v)(a) that there has been no changes made to the international trust;
 - (b) that there is no illegal activity perpetrated by the trust; and/or
 - (c) pending litigation against the trust."
